What is Pupil Premium?

The Government award 'Pupil Premium' funding to all eligible children.

All children in Reception and Year1/2 are entitled to a 'free' school lunch funded by the Government. This is different to Free School Meals (FSM) and you must apply for FSM to receive the benefits listed in this leaflet.

The school will use some of this money on your child, funding the initiatives mentioned overleaf.

Other money will be spent on supporting **ALL** children through the provision of additional support staff, paying for resources to enhance the curriculum and staff training.

Please note:

If you have received FSM in the past, your child will still have Pupil Premium status for six years.

Is my child eligible?

Your child might be eligible if you access:

- Income Support
- Income-based Jobseeker's Allowance or Employment and Support Allowance
- Support under part VI of the Immigration and Asylum Act 1999
- The guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on
- Universal Credit, provided you have an annual net earned income not exceeding £7,400 (after tax and not including any benefits you get)
